Government fee

1. List of all government fee in Registration

1.1. Registration fee:

- 0.8‰ for registered capital below 10 million Yuan (About 1.27 million USD)
- 0.4 ‰ for the exceeding part of registered capital over 10 million Yuan (About 1.27 million USD)

Cost

- 1.2. Character cachet : About 500Yuan (USD65)
- 1.3. Corporation code fee: About 200 Yuan (USD26)
- 1.4. Checking the capital fee: 2‰ of capital
- 1.5. Environment appraisal fees: About 4000–40,000 USD if your enterprises manufacture in the factory according to different types of enterprises, necessary only if plant setup for production.
- 1.6. Feasibility study report fee, 1000–10000 USD according to different total investment.

Notice: 1 USD=7.7RMB Yuan

Cost and Service

NO	service	Cost
1	Finish registration process (Guarantee success), include submit document to government and get approval of government	2,500 USD (Government fees not included)
2	Renting office and site selection of factory (Guarantee success)	1,000 USD for each office and 2,000 USD for each factory
3	Employ staff	100 USD for each staff
4	sourcing suppliers	1,000 USD for each qualified supplier

Cost and Service

Time

The Files that WFOE should be prepared

- A certificate of legal operation (transcript) issued by the competent authority of the country where the enterprise is located; Notarizing this certification at the China Embassy /Consulate in local;
- One copy of business license of investors
- Two original of credit worthiness of the investors issued by the foreign bank

Cont'

- One copy of identification card (or passport) of the board of the directors and general manager (vice one) of the junior enterprise. Their resume, address and telephone number will be needed. Each one should prepare two personal photos for being used.
- Three original of the resolution of the board of directors of the enterprise

Cont ' ,

- The Appointment and Authority should be signed by the legal representative of Investor
- Outline of the investor (total volume of revenue, operation scope, annual profit)
- If investor wants to stable the enterprise off producing or processing and Warehousing, one bank financial credit certificate of investors (needed the Original)

Cont '

- The prove file of leasing office and the title deed (copy).
- One original of financial statement (if the company has established more than one year, the statement needs to submit)
- The goods list of the export\import. (If none, won' t necessary report)
- The agent agreement signed with our company

Office

- Office renting is the first step in registration, we can help you find the office according to your requirement, it will usually take 1 week, warehouse and apartment is also easy to find but the time will depend on your requirement, usually in 7 days.
